



CWT Vacation Club “We’ll Turn Your Dream Vacation into a Reality” Sweepstakes Official Rules

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

THIS SWEEPSTAKES IS INTENDED TO BE CONDUCTED IN THE UNITED STATES ONLY AND WILL BE GOVERNED BY APPLICABLE U.S. LAW. ENTRY IN THIS SWEEPSTAKES CONSTITUTES ACCEPTANCE OF THESE OFFICIAL RULES.

ELIGIBILITY:

The CWT Vacation Club “We’ll Turn Your Dream Vacation into a Reality” Sweepstakes is open and offered only to CWT Corporate Vacation Club members and their employees who are legal residents of the 50 United States and the District of Columbia (excluding Puerto Rico), who are 18 years of age or older (except residents of Alabama and Nebraska who must be 19 years of age or older) at the time of entry. Void where restricted, or otherwise prohibited by law. Employees, officers, directors of Carlson Wagonlit Travel, and each of their affiliates, subsidiaries, advertising and promotion agencies, and other coordinating agencies (“Sweepstakes Entities”) and their immediate family members and those living in the same household are not eligible to enter. To enter the CWT Vacation Club “We’ll Turn Your Dream Vacation into a Reality” Sweepstakes, a Entrant must submit an entry via www.cwtvacationclub.com by signing in or registering for CWT Corporate Vacation Club, between Tuesday, January 16, 2018 at 12:00:00 noon Eastern Standard Time (EST) to Tuesday, March 13, 2018 at 5:00:00 p.m. EST. Entries will contain his or her first name, last name, email address, employer name, mailing address and opt in to receive the CWT Vacation Club enewsletter. All fields must be filled in correctly through sign-in or registration to be successfully entered. By entering the Sweepstakes, and opting in to receive the enewsletter, you are authorizing CWT to use your personal information only for identified purposes.

Limit one (1) entry per person/household. Entries are limited to individuals only; commercial enterprises and business entities are not eligible.
